



## **Ether Books Ltd. License Agreement**

This agreement confirms the terms on which you grant to Ether Books Ltd the non-exclusive Global right and license to publish the content submitted via the on-line submission form on the Ether Books Ltd WEB site. Future content submissions will be covered by this agreement.

Ether is a mobile licensor and publisher of short form reading content. Ether distributes this content via our mobile content delivery platform. This agreement provides Ether Books Ltd with the non-exclusive global right and license to publish the submitted content via any Ether APP or directly to consumers via Ether's mobile internet site. This agreement provides Ether Books Ltd with the non-exclusive global right and license to publish submitted content via Third Party APP Stores and Content stores operated by Mobile Network Operators, Handset Original Equipment Manufacturers, and mobile content aggregators.

Licensed mobile platforms will include all mobile and tablet devices including but not limited to: Apple iOS, Blackberry OS, Android OS, Meego OS, HP OS, Samsung devices and platforms, Windows OS, Dell, and all feature phone handsets.

Content licensee has the right to remove their content from Ether's content catalogue by providing Ether Books Ltd with e-mail notification requesting this contract to be terminated. Ether agrees to remove all licensee content within 90 days of receipt of Licensor email requesting termination of the agreement.

Ether Books Ltd agrees to pay licensor 20% of net receipts received from Ether Books Ltd distribution partners. Ether Books Ltd pays licensor three months in arrears and when a £25 threshold has been achieved. Statements will be issued once this threshold has been reached.

You confirm that you are able to grant such rights to Ether Books Ltd, that the works do not contain anything that is obscene, blasphemous, libellous, or otherwise unlawful, and that your content does not infringe any existing copyright or any rights of any person.

You agree that that Ether Books Ltd are entitled to publish your content on the Ether Books Ltd Mobile Content Platform at such prices and subject to such terms and conditions as we may determine, in our absolute discretion, and that we may make available free of charge excerpts from your content for the purposes of promoting and encouraging sales of your content.

You agree to provide us with all information requested in our submission form.

Ether Books Ltd agrees to notify licensor of acceptance or rejection of content within 90 days of content submission via Ether Books Ltd WEB site. Ethers Books Ltd agrees to include licensor content in our Global Content Catalogue and publish within the 90 days of receipt if content is accepted by Ether Books Ltd for inclusion, unless prevented from doing so by reason of events beyond our control. We will include the Copyright notice to indicate ownership of copyright by the licensor.



## **Ether Books Ltd. License Agreement**

Ether Books Ltd will accrue all royalties and pay when an amount of £25 has been reached. Ether Books Ltd will pay licensor via PayPal.

This agreement will automatically terminate if Ether Books Ltd goes into liquidation (otherwise than for the purpose of reconstruction or amalgamation.) You may terminate this agreement if we are in breach of any material obligation and fail to remedy that breach within 90 days of email notification from you asking us to do so.

This agreement is covered by English Law, and the English courts will have exclusive jurisdiction in the event of any dispute that cannot be resolved by good faith discussion between the parties.

Licensor agrees to all points in the terms & conditions agreement by submitting content to Ether Books Ltd for publishing consideration.
